FREQUENTLY ASKED QUESTIONS

Q: Who is eligible to apply for the FS Advisors Summer Internship?

A: Applicants must be currently enrolled in a bachelor's degree program (Finance, Business, Economics, or related field preferred) with a minimum GPA of 3.4. We welcome students who are passionate about finance and making a positive impact in Indian Country.

Q: Is this internship paid?

A: Yes, interns are compensated at \$18.00 per hour for 40 hours per week.

Q: Is housing provided?

A: Yes, housing is provided if needed for interns relocating to Pensacola, FL for the duration of the internship.

Q: What is the duration of the internship?

A: The internship runs from June 1 to July 31, 2026.

Q: What materials do I need to submit with my application?

A: Please submit the completed internship application, your resume, a cover letter, and an unofficial transcript.

Q: When will I be notified about the selection?

A: Selection notifications will be sent by March 31, 2026.

Q: What kind of projects will I work on?

A: Interns will rotate through multiple business lines, participate in mini-projects, and complete a capstone project focused on developing an AI User Guide for the firm. There will also be required reading and book reports throughout the 9 weeks.

Q: Will I receive mentorship or support during the internship?

A: Yes, each intern will be paired with a dedicated "Intern Buddy" for mentorship and will participate in weekly check-ins and feedback sessions.

Q: What professional development opportunities are available?

A: Interns will have access to career coaching, networking events with industry professionals, and opportunities to present their work to firm leadership.
